PUBLIC HEARING ON PROPOSED LOCAL LAW NO. FOUR (4) OF THE YEAR 2017 ENTITLED "FARM LIVESTOCK AND FOWL IN RESIDENTIAL SETTINGS"

(Continuing with Financial Report)

Tom reminded all that the budget worksheets are due on September 15th, and the first budget workshop is September 27th at 6pm.

Aurelia Pellettiere, our town tax collector, updated the board on the status of her tax records since there is excess money in her account due to a glitch in her tax software. She will advise the board when the issue is resolved so they can then go ahead and audit her tax records.

Agenda Item No. 4

Supervisor Lund asked the board for approval of the quote from JMap Services for the upgrade to the heating and cooling system in the town hall. There were only two quotes and the other one came in at \$41,000. Mr. Chartrand advised that the board needs to establish the funding for it. Mr. Lund explained that he had applied for grants from the County, \$35,000 for the walking path and \$35,000 for the heating and cooling upgrades. The money for the walking path came through first, but the County advised that he could switch the grants and use the money for the heating and cooling upgrades first. Mr. Lund had spoken to our highway superintendent, John Herold, and they had decided to hold off on the walking path until next vear.

Parks & Recreation

Gary Heymann was present in Ryan's absence. There was discussion regarding the water issue at Green Lake and dealing with the County. Ryan plans to do more research, but the County is okay with that for now.

Gary reported that the soccer program is up and running with good numbers, and for the first time in several years we have enough coaches.

There is one position open on the parks and rec board.

We are already advertising for basketball.

We have also talked about starting an online registration program called activekids.com for parents to be able to register their children for sports programs online, if they want to.

Councilor Speziale asked about the money needed for the baseball field and expressed his concerns as to whether they are going to have enough funds to finish the job. Brief discussion.

Highway

John Herold reported on the following:

- No large repairs this month on equipment
- Still finishing up our road repairs; cleaning our ditches
- All our sand has been pretty much hauled in for the winter season
- We've closed up Green Lake; it's been winterized
- Cleanup day this year is October 7th, the first Saturday of the month. Brief discussion.
- Finally, there was a brief discussion on the walking path as John explained that in the Fall the path will be used by the high school cross country team; we're heading into winter, and he would prefer to have enough time to start and finish the job within a reasonable period of time which is not going to happen this year, so he would suggest waiting till next Spring
- Dave Edwards will be retiring as of January 1st. Brief discussion followed.

Ambulance

Bryan reported on ambulance activities:

- EMS calls for August were 37
- CPR/AED training course was held on Sept. 12th for 15 people including Tully library staff, some staff from Riehlman, Shafer & Shafer and other businesses from their building
- Spoke to Onondaga County Personnel department about removing the names of four part-time staff members from the list since they are never available for open shifts
- I have been working on the 2018 budget figures for the workshop on Sept. 27th
- Had to have front tires replaced on Ambulance-1, and two new batteries installed on Ambulance-2
- Received an application for ambulance driver from James LeMessurier on Murphy Road

Fire

Floor

John McMahon asked about the status of the Comprehensive Plan. Our town attorney Steven Primo responded to the question by saying that it is "in limbo" right now. John asked if there were drafts available, and Steve responded that there were drafts, but not readily available.

Captain Ramsay asked if the town had been involved in shared services. Supervisor Lund responded that we have been involved and been practicing shared services for awhile. Brief discussion followed.

Legal

Supervisor Lund advised everyone that he had asked our town attorney to review a proposed contract between the Town of Tully and the Central New York SPCA for dog control services. Steve responded that he had reviewed the contract and that it was fine. So Mr. Lund suggested that the contract be reviewed during the budget session on September 27th since there would be a savings involved.

Supervisor Lund then asked if there was anything for the legal portion of the meeting this evening. There was discussion regarding the proposed local law on the keeping of chickens and other farm animals in the Town of Tully.
