## Message from the Supervisor

The Town Board and I certainly hope everyone is staying well and dealing with the challenges that this Corona Virus pandemic has created.

The Town Board has decided to postpone the reopening of Town offices, tentatively now set for the end of May. This will allow us time to re-evaluate any current dynamics related to public health, etc. We are accommodating the public's "needs" by individual appointment, as well as, monitoring email and phone messages on a regular basis. Since the opening of Town offices have no economic impact, we have been able to take a conservatively safe, yet practical approach.

We are conducting Town Board meetings and Planning Board meetings "virtually" via Skye with links provided on our Town of Tully web site. (townoftully.org)

With regard to "virtual meetings and hearings," I am most concerned about "Grievance Day." Another concern are "Public hearings" associated with the current solar projects. Please take special note of the following:

We are planning a virtual public hearing on the three "tier three solar sites" being developed by NB development. This meeting will be on 5/27/20 at 7 PM. Please see the posting on the Town 's website. Comments and questions can be submitted:

- 1- During the meeting
- 2- by email
- 3- by US mail

We are planning a virtual public hearing on "local law 3 a solar energy system pilot law" (payment in leu of taxes). This meeting is scheduled for June 10 at 7 PM, just prior to the regularly scheduled Town Board meeting.

The State of NY is allowing Towns to file tentative and final assessment rolls up to 30 days later than otherwise allowable. The Board has decided to take advantage of this opportunity. This will allow "Grievance Day" to be pushed into June, with the potential of a "normal meeting "rather than a "virtual meeting."

Please monitor the Town of Tully website - "townoftully.org." We are working diligently to keep the latest information available.

Also, it should be noted that the Highway crew has gone back to work, while taking appropriate precautions.

We are reevaluating the date of the popular "trash disposal day." We hope to provide dumpsters adjacent to the Village sewer plant in late July. Again, plans will be posted on the Town of Tully web site.

General John A. Logan's Memorial Day Order

#### **General Order**

No. 11

## Headquarters, Grand Army of the Republic Washington, D.C., May 5, 1868

I. The 30th day of May, 1868, is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village, and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances may permit.

We are organized, comrades, as our regulations tell us, for the purpose, among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors, and marines who united to suppress the late rebellion." What can aid more to assure this result than by cherishing tenderly the memory of our heroic dead, who made their breasts a barricade between our country and its foes? Their soldier lives were the reveille of freedom to a race in chains, and their death a tattoo of rebellious tyranny in arms. We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the Nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders. Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and fond mourners. Let no vandalism of avarice or neglect, no ravages of time, testify to the present or to the coming generations that we have forgotten, as a people, the cost of free and undivided republic.

If other eyes grow dull and other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain in us.

Let us, then, at the time appointed, gather around their sacred remains and garland the passionless mounds above them with choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us as sacred charges upon the Nation's gratitude,--the soldier's and sailor's widow and orphan.

II. It is the purpose of the Commander-in-Chief to inaugurate this observance with the hope it will be kept up from year to year, while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to call attention to this Order, and lend its friendly aid in bringing it to the notice of comrades in all parts of the country in time for simultaneous compliance therewith.

III. Department commanders will use every effort to make this order effective.
