Financial Report

Mr. Chartrand reviewed the Monthly Statement of Supervisor for July and reported on town clerk fees of about \$5,000; court fines are just about up to date for this time of year; the mortgage tax is less than usual for the first half of the year; we have received the county reimbursement for use of the old highway garage; we've also received \$1400 from the Girls of Summer Lacrosse league; ambulance recoveries are still doing very well. On the expense side, it was generally a quiet month. Tom also discussed transfers which are reflected in a transfer sheet below and include assessor's, town clerk's and joint youth project accounts.

Parks and Recreation

Gary Heymann reported that the summer has been great at Green Lake. We have scheduled regular hours through next Sunday and then will be tailoring the hours since we will be losing lifeguards who may be going back to college, etc. We are also getting ready for soccer in the Fall. In addition, we are seeking letters of interest for a position on the Parks & Rec Board since Ryan's seat opened up when he became director.

Highway

John Herold reviewed highway activities as follows:

- **We did some minor repairs on the roadside mower**
- Working on road repairs; also helping out other towns
- + Replacing cross culverts on Woodmancy Road
- Continue with ditching and mowing roadsides
- + New John Deere Pay loader did show up

Supervisor Lund discussed the roofing quotes John received for the town hall as follows:

It was noted that the low number from Martin Builders was based upon an approach to the existing problem, not involving the comprehensive scope of work contemplated by the other two contractors, but that all were made aware of the same specifics of the existing problems.

Ambulance

Captain Bryan Ramsay was not present this evening. Supervisor Lund reviewed the report as follows:

Total EMS calls for July were 54.

On Tuesday, August 2, 2016, Bryan attended the Onondaga County EMS Directors Meeting at which time he was asked to give a report on what Tully's plans are for coverage of the Otisco Fire District. As Bryan had explained to the other directors, at this time we will continue coverage until December 31, 2016 and the Tully Town Board and the Otisco Town Board will be working on a possible resolution during the next few months.

Bryan has been in constant review of the budget for this year. The ambulance crew has used more overtime hours than expected for the year. Because of this, Bryan has held off purchasing some items that they can do without at this time.

On page 10 of Tom's monthly report, the line items 4540.2 Equipment and 4544.4 Repair equipment are the areas for which he will be holding off some purchases. Bryan's thinking is to make the monies available for any additional overtime for the year as the staffing of the ambulance is the most important issue.

If we stay within the budgeted figure for overtime, then the monies will be spent for the supply items at the end of the budget year. This will not jeopardize the quality of our service in any way.

Fire

Sonny Battle reported that the truck is on the way to being delivered.

Supervisor Lund asked if we still have a public hearing next month, SEPT 12TH, on the floodplain local law, and if so, at what time. Mr. Primo responded in the affirmative and that it would be at 7:15pm.

Public Hearings Scheduled for Next Month

After a brief discussion, Supervisor Lund made a motion to have a public hearing next month to adopt a proposed local law amending NYS Building and Construction Code sections and adopting the International Uniform Code. Councilor Speziale seconded the motion. Mr. Primo advised that it would be proposed Local Law No. 2 of 2016 and that the public hearing would be scheduled for 7:00pm. The motion carried 3 ayes (Lund, Masters, Speziale) 0 nayes. (**RESOLUTION 66-16**)

Mr. Primo also advised that we need to have a public hearing at 7:15 to consider the adoption of Local Law No. 3 of 2016 repealing Chapter 162 of the Town of Tully Code entitled, "Flood Damage Prevention" and replacing same with a new Chapter 162 entitled, "Flood Damage Prevention."

Floor

Carl Rosato, a local resident, addressed the board regarding a piece of property on Green Lake that he and his wife would like to purchase. After a brief discussion, the three board members present agreed that it was not a good idea and it would be in the town's best interest to own the land along Green Lake.

Legal

Town Attorney Steve Primo reported to the board that we have had the first application on a large scale solar project, "and so far, so good." The process has run relatively smoothly. There was a question regarding notice to adjacent landowners to which Mr. Primo responded that landowners within 1500 feet of such a project must be served by mail. In addition to that, the property is posted with a sign indicating the date of the public hearing.

Resident John McMahon had a question about Local Law No. 1 which was recently adopted by the board. A lengthy discussion followed.

Mr. Primo advised the board that he needed something on the record regarding the Aldi Certiorari settlement. It was discussed during executive session in the past, but we need something on the record of the board ratifying settlement of the Aldi Certiorari case upon the terms and conditions stated in the stipulation of settlement.

He advised that he really needs the board to approve this and understands the board members may have reservations about doing that.
