## Cornerstone Park Project is Moving Again

Cornerstone Park Construction has been reinvigorated with multiple layers of grants, private donations, fundraisers and the Engraved Paver Campaign. In the grants division, many thanks go to Supervisor Bill Lund who procured a \$50,000 State Grant after several years of negotiations with State Senator David Valesky and the NYS Dormitory Authority Officials. Also, Town Lawyer, Steven Primo, was very helpful with the legal documents and affidavits needed for the State Grant Application. While things never move quickly in Albany, Mr. Lund never gave up on his desire to help build the park. This grant will be utilized to begin construction on the interior of the park. In addition to the State grant, several smaller Grants were received from Rosamund Gifford Foundation (\$2,000), Alliance Bank (\$500) and a donation from Aldi Corp for \$1000.

**Private Donations:** While waiting for the State Grant to come through, the Tully Action Group (TAG) was able to initiate construction on the east wall and other elements planned within the East and South boundaries such as the fountain and the Cornerstone Name Wall. These elements

were made possible partly due to several generous private donations from Tully residents who expressed concern over the lack of progress this summer. Like Mr. Lund, they never stopped believing in the project.

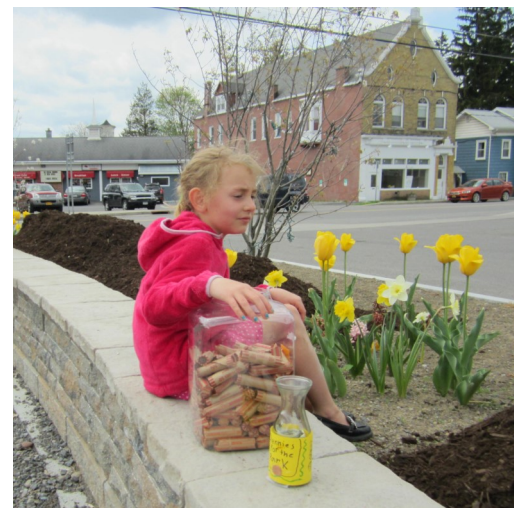
**Fund Raisers:** It is with great joy that TAG recognizes a second grade student, Sophia, who conceived of a way to help with Cornerstone progress with her Pennies for the Park Project. Penny Jars were placed in various businesses and locations around the village. She and her family added Slushie and Snow Cone sales at the farmer's market last August. Those pennies are still adding up very quickly. Many other Tully residents helped in a variety of ways by supporting the Tully Action Group Fund Raisers (five each year) and these required hours of planning and labor on the part of the dedicated foot soldiers. A Special thanks also goes out to Tully Lakes Hardware for hosting the Mother's Day Hanging Basket Sale for the second year.

**Engraved Paver Campaign:** TAG made a major decision this year to use the south entry way at Elm Street as a Celebration Walkway. The engraved pavers that will be used in this walkway will provide a way for residents to place an enduring tribute to family members, businesses, historic figures or buildings. This Campaign has been well received with at least 170 pavers ordered. The deadline for a paver order has been extended until the first of March 2017, with plans to set this walkway early in 2017. Application for engraved pavers may be picked up at Town Hall or by calling

While you have been shopping in the Village over that past several months, you may have seen "Pennies for the Park" jars for your spare change. Sophia Lucas has been working to raise money in support of TAG's efforts to revitalize the corner lot at the center of the Village as the new Cornerstone Park. In mid-October she passed \$900.00 in funds raised for this effort! We are so thrilled at her hard work and dedication to making Tully a more beautiful place to live. 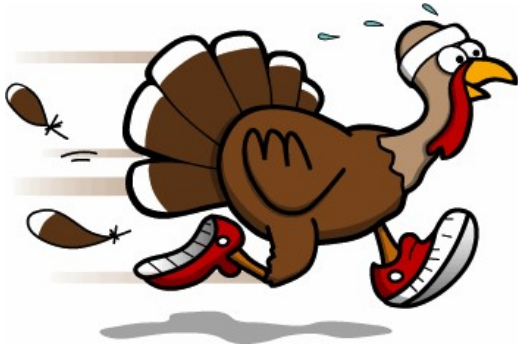

# Notice of Continuation of Public Hearing for Town Of Tully

PLEASE TAKE NOTICE that the Public Hearing relative to the below application will now be continued—HOWEVER, SUBJECT TO THE FOLLOWING CONDITIONS — and held by the Joint Planning Board of the Town and Village of Tully, Onondaga County, New York, on the 30th day of November, 2016 at 7:00 P.M. at the Municipal Building, 5833 Meetinghouse Road, Tully, New York to consider the following:

The application of James A. Potter and Cheryl E. Potter for Special Authorization pursuant to Town Code §280-11.1, Site Plan Review pursuant to §280-9B, and as needed, Subdivision review pursuant to Town Code §245, to construct a solar energy project consisting of an approximately 2.8 megawatt direct current (MWdc) solar photovoltaic (PV) facility. The Project is proposed to be located on an approximately 11 acre portion of approximately 126 acres of land owned by the applicants on North Road and identified as Tax Map No.: 114-01-06.1. The subject premises are located in a Residential-2

zoning District.

Persons wishing to appear at the hearing may do so in person, by attorney or other representation. Communications in writing in relation thereto may be filed with the Board, or at such hearing.

PLEASE TAKE FURTHER NOTICE that the environmental significance of the action will be reviewed pursuant to SEQRA by said Board incident to said hearing. The Action is a Type I Action and the Planning Board has assumed Lead Agency status.

PLEASE NOTE THE PUBLIC HEARING HAS BEEN CONTINUED FOR A NUMBER OF REASONS, INCLUDING TO PERMIT ONLINE ACCESS TO THE COMPLETE APPLICATION AND UPDATE VIEWSHED STUDY AS DETAILED AT THE AUGUST 24TH PUBLIC HEARING. PLEASE CONTINUE TO MONITOR THE TOWN'S WEBSITE FOR A LINK TO SAME. THE APPLICATION WILL BE DEEMED AS INCOMPLETE AND ABANDONED AND THUS DISMISSED WITHOUT PREJUDICE UNLESS THE FOLLOWING CONDITIONS ARE SATISFIED

IN FULL PRIOR TO NOVEMBER 20TH 2016:

- A) Receipt of updated viewshed study per Planning Board directions at THE August meeting.
- B) Corrections to any application and SEQRA errors or omissions as raised at August and July meetings;
- C) Town website link provided for review of complete application;
- D) Complete hard copies of all application and supporting documents provided to each Planning Board member at the home addresses provided previously and with not less than three (3) hard copies provided to the Planning Board attorney plus an additional copy for each Involved Agency cited in the application; and
- E) Payment of the application fees, attorney's fees and engineering review fees previously noted and signed professional fees agreement.
