In the absence of Fire Captain Chad Wakula, the ambulance report was read by Supervisor Masters:

Parks & Recreation

Sarah Panzarella reported on parks and rec activities: they are going to have umpire training this year for several towns since there has been a shortage of umpires for games in the past. Training will take place on two Sundays, March $3^{\rm rd}$ and March $10^{\rm th}$ from 12 to 5 and on Wednesday, March 6th from 5:30 to 8:30pm. Our baseball program starts May $6^{\rm th}$.

Basketball program is running now.

Sarah also reported that she had reached out to lifeguards to ask them to commit to the upcoming summer program for our town as well as Lafayette, Fabius and Pompey. More info to follow.

Fire

Update from Assessor

Town Assessor Cris DelFuoco was present this evening and reviewed the latest changes to the laws for the Partial Property Tax Exemption for Seniors with Limited Income, the Partial Property Tax Exemption for Disabled Persons with Limited Incomes, the Volunteer Firefighter/Ambulance Worker exemption, and the changes that have been adopted by Onondaga County. Lengthy explanation followed with questions by our town supervisor. It was decided by the board that they would get together a plan for acting on these changes by 2025.

There was also a lengthy discussion regarding the firefighter exemption with questions and comments by Mr. Masters and Councilor Speziale.

Update from New Codes Officer - Ben Vincent

Ben was introduced by Supervisor Masters and stated that he had been updating forms: zoning, site plan, building permit applications, and info on the website. He also mentioned a solar farm up on Sky High Road and suggested that Mr. DeMore would be able to give more information and suggestions on that.

Town Attorney Robert DeMore suggested for a 5-megawatt community-based solar farm a fee of \$1500.00 would be appropriate and for anything larger, we should make the fee \$2,000. Brief discussion followed after which came the following motion:

RESOLUTION 42-24

Motion to approve amending the building code fees for solar farms up to 5 megawatts to \$1500, and above 5 megawatts would be \$2,000. Motion was made by Supervisor Masters and seconded by Councilor Snavlin. Motion carried.

And finally, Mr. Masters announced he would like to invite Steve Bailey to our next meeting and give him a plaque in recognition of his many years of service as a town justice.
