Financial Report

Tom Chartrand reported on receipts and disbursements for the month of June:

Highway

John Herold reported on the following:

- Busy month; there was one repair
- Most of the oil and stone is done and the paving is done.
- We've done some roadside mowing, first time around; done some paving for the year
- > Culvert on Woodmancy Road is finally being replaced this year; brief discussion

John Herold also advised that during a Village board meeting, it was brought up that our Town highway department would help the Village department with a project, particularly, with ditching behind the sewer treatment plant. Thereafter, he said there was apparently a miscommunication between the two department heads. Since then, they both met with the mayor, and the issue has been resolved. Brief discussion followed.

Ambulance

Fire Captain Chad Wakula reported on the following ambulance activities:

- 1. Number of EMS calls for May was 37.
- 2. I have received both our NYS Department of Health ambulance operating certificate and our controlled substance license. We are good until July 2023.
- 3. Modems and Wi-Fi cards were installed in both ambulances as well as the medic car. They were paid for by Onondaga County. Our only cost will be the monthly data charge through Verizon Wireless.
- 4. Dan Holbert was promoted to full time firefighter paramedic from part time to replace Charles Iavarone.
- 5. We are actively seeking volunteer ambulance drivers.

Floor - Public Input

Councilor Goodwin had a resident approach her about the speed limits on Long, Lake and Gatehouse roads and wondered if we had heard anything from the DOT. Supervisor Masters responded in the negative. Brief discussion followed.

Information from Supervisor

Mr. Masters advised that the Village mayor, Melissa Flint-Morgan, had offered some community development money that was not going to be used, and she offered it for the train station renovations. So both the Mayor and the Supervisor approached the County with the idea, and they were amenable to it, but advised that it would have to go through the proper channels. Brief discussion followed.

Legal

Supervisor Masters suggested the road dedication be discussed first. The road will be called "Hazel's Way" which was formerly part of Tully Center Road heading south toward Meeting House Road and Walburger's garage. Although the town road was previously abandoned, the cost of adopting the road will be borne by the developer, so that none of that will be on the taxpayers.

Town Attorney Robert DeMore advised that the town board should be appointed as lead agency for the SEQR process.

Whereas on June 9, 2021 the Tully Town Board voted to adopt a conditional consent, a copy of which is attached hereto, to layout a highway as stated in the application of Theodore V Shaw and Self Storage Meeting House Road, LLC and

Whereas the terms of the conditional consent have been substantially met by the applicants

Now, therefore, be it

Resolved, that in accordance with the provisions of Section 171 of the Highway Law, consent hereby is given that the Highway Superintendent make an Order laying out the proposed highway described in said application as delineated on a survey provided and that the terms of the agreement for the construction of the highway as entered into between the Town and the applicants be fully enforced and complied with and be it further

Resolved, that the name of the Highway shall be "Hazel's Way," and be it further

Resolved, that the Town Board accept the conveyance of said lands, and be it further

Resolved that the terms and conditions of the conditional consent aforementioned be fully complied with as set forth therein.

The above consent having been moved by the Town Supervisor, John Masters, at a regular meeting of the Tully Town Board on July 14, 2021 and a vote having been taken and the Board having voted in the affirmative adopting this Consent.
