- ➤ On the general spending, we're at about 78%; revenue is at 101%
- > Highway spending, we're at 72%; revenue is 112% which is mostly CHIPS money
- Ambulance spending, we're at 69%; revenue is at 104%.
- > So we're having a banner year for revenues.

Ambulance

Fire Captain Chad Wakula reported on the following ambulance activities:

- 1. Number of EMS calls for October Was 49
- 2. Part Time Paramedic Vincent Stevenson Passed Away On October 18, 2021. He Was The Current And Longstanding Director Of Eaves Ambulance In East Syracuse. Members Of The Career Staff Attended Services. Tully Also Provided Ambulance Coverage To Eaves On October 22nd So Their Members Could Be Off Schedule.
- 3. November Schedule Looks Good With Only A Couple Openings.
- 4. All 3 Vehicles Are Being Prepped For Winter Weather.

Parks & Recreation

Ryan Dando reported as follows:

- We have finished all Fall programs
- > The Cornfield Classic is this weekend
- > Restrooms are shut down
- Rich Edinger and Bill Hardy of the lacrosse club asked if they could put a storage container on the field next to the tennis courts to store their equipment. Discussion followed after which it was decided to table the matter for now and discuss it at the next meeting.

Fire

Ben Bibik reported briefly on rescue pumper 15 being back in service, but it's taking 20 weeks to get parts. Brief discussion.

Floor - Public Input

Ben Bibik also reported that he and Joey Nemire(sic) were asked by residents why they didn't have a chance to opt in or out of the cannabis law. Brief discussion.

Information from Supervisor

Mr. Masters and John Herold, highway superintendent, met with the teamsters today. They had asked for a salary increase of 3% the first year, 2% the second year and 2% the third year. Also discussed was extending the existing health care plan for five years, and that was denied due to the excessive cost. Also agreed to was a clothing allowance and uniforms. Supervisor Masters felt it went very well. The union rep will provide the town with written documentation for our town attorney to review.

Concerning our insurance, we received a notice of policy conditional renewal from NYMIR. Brief discussion followed regarding liability and personal identity coverage being separate from the remainder of the insurance policy and its coverage.

Next, appointment of a fire commissioner. Craig Clemons was appointed to fill Sonny Battle's term when he retired. Brief discussion ensued after which all board members agreed it would be a good idea to place an ad in the Tully News.

Legal

There was discussion regarding the Rte. 11a water district which, Mr. Masters advised, is very close to transacting with Honeywell to close the deal for them to provide the \$2.2 million. Some discussion ensued as to the agreement on disbursement of the grant funds.
