#### Legal

Attorney Steven Primo suggested the first order of legal business be the adoption by the board of a blanket undertaking. There was a lengthy discussion after which the resolution included below was adopted.

### RESOLUTION No. 11-2015

The Town Board Members of the **Town of Tully**, in the County of Onondaga, State of New York, met at a regular meeting held in the Municipal Building, located at 5833 Meetinghouse Road, Tully, on the  $11^{\rm th}$  day of February, 2015 at 7:30 p.m.

The following resolution as drafted and proposed by the Attorney for the Town, was moved, seconded and adopted:

WHEREAS, at the 2015 Organizational Meeting of the Town of Tully Town Board ("Town Board") held on January 14, 2015, the Town Board approved a blanket undertaking bond covering all Town officers, clerks and employees as required by Section 25 of the Town Law resolving specifically that an official blanket undertaking be procured instead of individual undertakings covering the Town Supervisor, Town Clerk, Collector and Receiver of Taxes, Justices of the Peace, Town Superintendent of Highways, Town Bookkeeper and Budget Officer, Town Zoning and Enforcement Officer, Fire Marshall, and that such undertaking contain provisions indemnifying against losses: (a) through the failure of the officers, clerk and employees covered there under to faithfully perform their duties or to account properly for all monies or property received by virtue of their positions or employment, and (b) through fraudulent or dishonest acts committed by the officers, clerks and employees and covered there under

WHEREAS, as to such undertakings, Section 25 of the Town Law specifically provides: "Each supervisor, town clerk, collector, receiver of taxes and assessments, town justice, constable, town superintendent of highways, and such other officers and employees as the town board may require, before entering upon the duties of his or her office, and within thirty days after commencement of the term for which he or she is chosen, shall execute and file in the office of the clerk of the town, an official undertaking, conditioned for the faithful performance of his or her duties, in such form, in such sum and with such sureties as the town board shall direct and approve and such approval shall be indicated upon such undertaking. Unless the town board of his or her town has procured a blanket undertaking pursuant to subdivision two of section eleven of the public officers law that covers him or her, each town justice shall also file such undertaking as provided by section one hundred four of the uniform justice court act with the county clerk. Such undertaking shall not be recorded unless the town board of the town shall adopt a resolution so requiring and shall indicate such requirement upon such undertaking"; and

WHEREAS, Section 11(2) of the Public Officers Law provides specifically that "Notwithstanding the foregoing provisions of this section or any other law, general, special or local, requiring an official undertaking to be conditioned substantially to the effect that an officer, clerk or employee will faithfully discharge his duties and promptly account for and pay over all moneys or property received by him in his official capacity, it shall be permissible in lieu thereof, with the consent and approval of the officer or governing body authorized to require the undertaking, for any department or agency of the state or any municipal corporation or district corporation or department or agency thereof to procure a blanket undertaking from any duly authorized corporate surety covering officers, clerks and employees"; and

WHEREAS, the Town Board desires to make clear those officers, clerks and employees covered under such blanket undertaking approved at the January 14, 2015 Organizational Meeting including as permitted under Section 25 of the Town Law and as required by Section 11(2) of the Public Officers Law; and

NOW THEREFORE, BE IT RESOLVED, the blanket undertaking approved at the January 14, 2015 Organizational Meeting of the Town Board is intended to and shall cover all officers, clerks and employees of the Town so required to post undertakings and in addition, as permitted under Town Law Section 25, all such employees, clerks and officers of each department or part of Town government, including without limitation the Town Justices and Town Justice court, each of the foregoing department, part and justice courts respective deputies, clerks, secretaries, assistants and the like having access to Town, resident or other funds and property held by the Town and thus subject to theft, misappropriation, defalcation, loss or waste and otherwise intended, contemplated or eligible for coverage thereunder and including without limitation that such undertaking contain provisions indemnifying against losses: (a) through the failure of such officers, clerks, employees and other persons aforementioned to faithfully perform their duties or to account properly for all monies or property received by virtue of their positions or employment, and (b) through fraudulent or dishonest acts committed by such officers, clerks, employees and other persons aforementioned it having been and being the intent of the board to extend such coverage in the broadest and most comprehensive manner to all such officers, clerks, employees and other persons aforementiond and to ensure its blanket undertaking provides such coverage; and it is

FURTHER RESOLVED, a copy of this resolution be delivered to the surety or insurer's representative for the Town for the purpose of ensuring and confirming such coverage has been and remains in place, full force and effect from its effective date, not later than January 1, 2015.
